

## Trusty Portal Privacy Policy

TrustyPortal.com is operated by R. Miller Consulting, LLC (“we,” “us,” or “our”). We respect the privacy of every visitor to our Web site and user of our service. Your privacy is a priority, and we go to great lengths to protect it. The following information explains our information practices.

### Data Collection

You may view the Web site without providing any personal information that, alone or in combination with other information, could reasonably be used to identify you. At this time, we do **not** collect personal information from you when you visit our Web site. We do collect non-identifying information such as the number of visitors to the Web site, pages viewed, time spent on pages, anonymized referral sources, and usage behavior. This allows us to compile anonymized, aggregate data that we can then use to make Web site improvements.

We only collect personal information that you voluntarily provide to us through the Web site or in the course of a business relationship with Trusty Portal. When you provide personal information to us via this or any other means, we will use this information to respond to your requests.

Should our data collection practices change, we will update this Privacy Policy and we will not collect any personal information before the new Privacy Policy is published.

### Data Sharing

Generally, we do not share the personal information collected through the Web site with third parties unless we have obtained your prior permission. However, we may share this information under the following circumstances without prior notice or permission: (i) with our business affiliates; (ii) with agents and contractors that assist us in administering the Web site and in providing our products and services to you; (iii) in response to legal process or when we believe in good faith that the law requires it (for example, in response to a court order, subpoena or a law enforcement agency’s request); (iv) to protect the rights, property or safety of Trusty Portal, the Web site, users of the Web site and others; or (v) in connection with a transfer or sale of assets or ownership to another entity.

### Cookies

A “cookie” is a piece of information stored on your computer or cell phone. Although cookies are used for a variety of purposes, our Web site only uses temporary “session” cookies that do not contain any personal information about you and they are automatically removed from your

computer or cell phone once you leave our Web site, close your browser, or perform no activity on the Web site for a period of 20 minutes. If you do not want cookies to be used while you are using the Web site, you can deny or accept the cookie feature on your computer by using a simple procedure available in most browsers. However if you block cookies, you may lose some Web site functionality.

### Links to Other Sites

Our Web site may contain links to other Web sites that are not under our control. We do not endorse any such Web sites, and this Privacy Policy applies only to your use of this Web site. We have not reviewed the privacy policies of any Web sites linked to this Web site, and you should read the privacy policies of each Web site you visit to determine what information about you that Web site may collect and use.

### Access and Deletion Rights

Given that we do not collect any personal information about visitors to our Web site, we do not have any data that would be subject to access, deletion, or other individual rights afforded by the California Consumer Privacy Act (“CCPA”), the EU’s General Data Privacy Regulation (“GDPR”), or other comparable statutes and regulations. Should our data collection practices change, we will implement the necessary protocols and modify this Privacy Policy accordingly.

### Children Under the Age of 13

Our Web site is not intended for children under 13 years of age, and we do not knowingly collect personal information from anyone under 13 years of age. If you are under 13 years of age, please do not use or provide any information on our Web site. If we learn that we have collected or received personal information from a child under 13 without verification of parental consent, we will delete that information.
